MEMBER NEWSPAPERS COLLECT 58 MERIT AWARDS

GARY, IND. - Twenty five NNPA member newspapers won 58 awards and public acclaim for their "well done job" during '82. Their recognition was the highlight of the annual Merit Awards Dinner here, which culminated the 43rd Annual Convention of the National Newspaper Publishers' Association. A three day event, it was held at the Gary Sheraton Hotel. The Gary Crusader and the Gary Info, Dorothy Leavell and Imogene Harris, publishers, were the host newspapers.

Of the 19-categories, the Miami Times was first in both the number one and two listed SPOTS, winning "The John H. Sengstacke" Award for General Excellence and the "Robert S. Abbott" Award for Best Editorial. The Afro-American was second and the Philadelphia Tribune was third in the General Excellence class. The Michigan Chronicle and the Winston-Salem Chronicle were second and third in the Best Editorial class. The judges awarded the Emory O. Jackson" Best Column Writing Award to The Chatham South-west Citizen. The Augusta News-Review

was second and the Orlando Times was voted third. "The Carl Murphy Community Service Award" went to the Richmond Afro-American with second place going to the Milwaukee Courier and third to the Buffalo Challenger.

The cash awards, ranging up to \$500 to 1st place winners in the 19-categories, with \$300. for second and \$200. for third, and \$1000 for Publisher of the Year, comes from an Award Fund.
