To Be Equal **TUITION TAX CREDITS A** BADIDEA

One of the strangest responses to the concern about the decline of public America's schools is the renewed Interest in giving tax breaks to parents of private school students.

The Administration is pushing a tuition tax credit plan. There is considerable support for it in And the Congress. Supreme Court recently approved a version of tax breaks for parents of school children.

Previously, the Court struck down such state laws on the grounds that they violated the constitutional ban on government involvement in religion by subsidizing parochial schools.

In the Minnesota case recently decided by a 5-4 vote, the Court found that since the state offered a tax deduction for school-related expenses parents to all with children, school the state law passed the test of constitutionality.

In effect, what the Court did was to show backers of a tuition tax credit how to recast their pet plan to meet constitutional objections. The key is to extend the credit to all parents, not just those with kids in private school.

Of course, that's just a legal fiction. The expenses incurred by public parents are school minimal. Pencils, notebooks and gym shorts don't add up to a fraction of the tuition payments for which private school parents would get a tax credit.

The Court might still strike down a federal tuition tax credit - it

would just take a change of mind by only one Justice. But that's a slim hope now. Supporters of public education would

be advised to try to ensure such legislation never gets past the Congress.

For a tuition tax credit would be a body blow to public education. Its effect would be to drain tax dollars away from already financially un-See JACOB. Page

It I interpreted Paul Price's question right in his last week's column concerning the Tatum murder, everyone who owns a twenty-five automatic pistol is a murder suspect irrespective of whether or not they have a motive. If I interpreted Paul Price correctly, he attempted to move the Governor and the State Attorney General to take action against Lt Lovelle Gaines for not allowing "Metro" to run ballistics tests on Gaines' private weapon.

I happen to believe that Gaines is correct in not allowing "Metro" to run ballistics tests on his weapon. If "Metro" wants to conduct such tests, they have at their disposal the means by which they can acquire such tests.

The place where Tatum's body was found had motor cycle tracks in the area. It would seem to me that maybe Mr. Price should have made a cast of all those motor cycle tires, especially those owned by prison guards.

There is a point in any investigation where one must come to the conclusion that he has enough evidence to file a charge or he does not. Lt. Gaines and Sgt. Clyde Johnson have been investigated by "Metro" and a prison Critical Review Board and now I understand that there is a Captain at the Southem Desert Correctional Center, who has allegedly taken it upon himself to conduct his own investigation into the white prisoners' complaint that Gaines and Johnson violated their civil rights. I find this investigation to be a strange one, because the Director of Prisons had already appointed a Critical Review Board. This Critical Review Board has cleared Gaines and Johnson of any violations of prisoners' rights. But yet, this Captain has requested that certain black guards rewrite their statements pertaining to these charges.

This whole affair at the Southern Desert Correctional Center is turning into a "get Gaines." suggest that "Metro" look at some of the other persons in the prison system besides Gaines. Maybe "Metro" should take a look within its own house. They might ask themselves some questions about the Tatum matter. Did "Metro" have a man working at the prison where Tatum worked? Did Tatum have contact with this person? Was the narcotics undercoverman allowed to handle drugs to secure his cover? Why did Tatum go to New Mexico on vacation just before his death? Where is the weapon issued to Tatum out of the prison stock? What happened to the pen register on the prison telephones the night Tatum was murdered? How much insurance did Tatum have on his life? Who collected It? Did "Metro" know of Tatum's death before his body was discovered? Was a cast made of the motor cycle tracks found near Tatum's body?
