## PART VII - OUR CHILDREN . . . THE QUEST FOR EXCELLENCE - A QUEST FOR TRUTH

Having decided to engage in some reflection and introspection about the more than thirty "conversations" initiated in this series, I was led to repeat Dr. Shriver's poignant question. Because it serves to best describe the context out of which these "conversations" have emerged, it is presented here for your closer investigation of the meanings it may hold for you. In a sense, I am reaching for your indulgence and asking you to think with me in examining some of the thoughts in our discussions during the year.

Let me hasten to say that I do not presume that all of the discussions in the series have held the same meaning for every reader - surely the meaning will vary with the experiences that each reader brings to the information shared.

For some, the "conversations" might serve to reaffirm their own perceptions and/convictions, even actions while for others, they might serve to open new avenues of thought and consideration (they have served in both ways for - helping me to "look at old problems in new ways").

Still, there will be others whose mind-sets and experiences may produce differing views from these expressed in the "conversations."

Also, we must consider those factors which make up one's experiences; for instance, we will find varying degrees of awareness, Blackness, motivation, love, hate, bitterness, complacency, concern, spirituality, commitment, fear, contentapathy, ment, selfishness, dedication, involvement, etc.

Ultimately, the question for us becomes: What do we value the most?

Finally, whatever response or action might result from any discussion of the contemporissues affecting Black families in this decade, we must all be willing to "test" our responses and actions against the inevitable truths which bera directly on the final judgment - in all matters requiring

our serious thought and action.

Explore with me now some of the thoughts which evolved in our former discussions. Let us search, together, for the common base of truth and reality. Moreover, let

us begin to identify with the issues raised on some very concrete levels that represent specific actions that we are already taking or that we can begin to take in meeting the challenges before us.

On reflecting -

• If I were asked what I believe to be the single most important issue confronting the Black family in today's society, I would respond: It is the need to rebuild and strengthen torn-down family units - to re-evaluate and re-establish the spiritual and moral relationships within our immediate and extended families, wherever these relationships are found to be weakened or falling off.

. "Today, the role of the Black family is more important than it has ever been. There are more elements in our society dedicated to the weakening and destruction of the family than there has ever been. Economic depression, social and political upheaval, unemployment, delinquency, drugs, crime are but a few of the devisive forces. The general moral laxity, lack of honesty and integrity, the dog-eat-dog quality of our lifestyle all add to the negative side of the ledger . . . For these and many more reasons, it is absolutely imperative that the Black family regroup, close ranks and reaffirm love, unity and togetherness that has sustained us thus far, and will continue to sustain and keep us as long as the traditional Christian Black American family survives."
