BIDS WANTED FOR HIGHWAY IMPROVEMENT NOTICE TO CONTRACTORS

Sealed proposals will be received by the Directors of the Department of Transportation of the State of Nevada at their District 1 Headquarters Office located at 1200 North Main Street, Las Vegas, Nevada, 89101, until 10 a.m., local time, on the 20th day of December, 1983, for Contract No. 1998 (Readvertised), Project Nos. IR-015-1(68)38 & M-592(6), construction of a portion of the interstate Highway System in Las Vegas on Interstate Route 15 at the Flamingo Road Interchange and on Flamingo Road between Valley View and Interstate Route 15, Clark County, a length of 0.228 miles. Such sealed proposals as are received will be publicly opened and read at 4:00 p.m., local time, on that date. D.B.E. and W.B.E. information as required in subsections 102.03 and 103.02 of the Special Provisions and Supplemental Notice to Contractors No. 1 shall be submitted no later than the time of opening of proposals as specified above.

SPECIFIC DESCRIPTION OF WORK COVERED BY THIS CONTRACT CONSISTS OF: REMOVING AN EXISTING INTERCHANGE STRUCTURE AND RAMPS AND CONSTRUCTING A NEW INTERCHANGE STRUCTURE, CONSTRUCTING TWO GRADE SEPARATION STRUCTURES, EXTENDING EXISTING DRAINAGE STRUCTURES, CONSTRUCTING A HIGHWAY LIGHTING AND SIGNAL SYSTEM, REALIGNING AND SURFACING FLAMINGO ROAD, CONSTRUCTING INTERCHANGE RAMPS WITH SURFACING AND REALIGNING AND SURFACING EXISTING FRONTAGE ROADS.

The minimum wage to be paid on this contract shall be as determined by the Secretary of Labor or the State Labor Commissioner and are set forth in the contract documents.

Plans, form of proposal, contract and specifications may be secured by prequalified bidders through the office of the undersigned. A fee of Twenty Dollars (\$20.00) is required for the purchase of each copy of the plans with proposal form. Plans, proposal form and specifications obtained on this basis are non-returnable and no refund will be made. Bids must be on the proposal form of the Department of Transportation and must be accompanied by a bid bond, a certified check, a cashier's check, or cash in the amount of five percent (5%) of bid.

Right is reserved to reject any or all bids.

Contractors desiring to bid on this work, if not already qualified under the State Law, shall file with the Department of Transportation at Carson City, Nevada, not later than five (5) days prior to the date for opening of bids, a complete application for qualification on form furnished by the Department. All requests must be made in writing on the standard printed form provided free of charge for that purpose by the Department of Transportation.

The attention of bidders is directed to the State Contractor's License Law requirement (NRS 624.230 as amended to date), that a contractor hold a valid license of a class corresponding to the work to be done. Requests for license may be directed to the Secretary of the State Contractor's Board, 70 Linden Avenue, Reno, Nevada 89502.

This is a Federal-aid project and as such, any contractor otherwise qualified by the State of Nevada to perform such work, is not required to be licensed nor to submit application for license in advance of submitting a bid or having such bid considered; provided, however, that such exemption does not constitute a waiver of the State's right under its license laws to require a contractor, determined to be a successful bidder, to be licensed to do business in the State of Nevada in connection with the award of a contract to him.

The State of Nevada De-

partment of Transportation will on its own initiative, take affirmative action, including the imposition of contract sanctions and the initiation of appropriate legal proceedings under any applicable State or Federal law to achieve equal employment opportunity on Federal-aid Highway Projects and will actively cooperate with the Federal Highway Administration in all investigations and enforcement actions undertaken by the Federal Highway Administration. In conjunction with the above statement, the Department of Transportation will not issue plans to

an irresponsible bidder. Subsection (B) of the section 112 of Title 23 United States Code has been amended by adding at the end thereof, the following: "Contracts for the construction of each project shall be awarded only on the basis of the lowest responsible bid submitted by a bidder meeting established criteria of responsibility."

There will be a pre-bid conference on this project. The conference will be held in Las Vegas, NV on December 13, 1983, at 1:30 P.M., local time, at the District 1 Headquarters Office, 1200 North Main Street, Las Vegas, NV 89101. The pre-

bid conference is open to all interested parties and is being held for the purpose of discussing the M.B.E. program, the plans and the specifications. The conference will also provide the opportunity to inform M.B.E.s of subcontracting and material supply opportunities. Attendance at this conference is a prerequisite for demonstrating reasonable effort to meet the goal of M.B.E. participation.


Each bidder must deposit with his bid, security in the amount, form, and subject to the conditions stipulated by the Owner.


No bidder may withdraw his bid within sixty (60) calendar days after the actual date of the opening thereof.


