Cannon" Shannon Pleads Innocent

Professional boxer Willie "The Cannon" Shannon pleaded innocent Monday in District Court to charges of raping a woman in the restroom of a North Las Vegas park.

Shannon, 32, pleaded innocent to charges of battery, first-degree kidnapping and sexual assault during an arraignment before Judge Donald Mosley, who scheduled Shannon's trial to begin Feb. 27.

Shannon, a boxer in the light heavyweight division, is accused of raping a 29-year-old woman on Oct. 19 in the women's restroom of City View Park on Cheyenne Ave.

He also is charged in the criminal complaint with twisting the woman's arm and dragging her in a chokehold from a car and into the restroom. The woman told police she was on a date with the fighter and after driving around for a while they wound up at the park.

In September, a District Court jury acquitted Shannon of sexually assaulting a 14-year-old girl at an apartment of a friend.
