# "Cannon" Shannon Irks Prosecutor

A deputy district attorney Monday accused former light heavyweight boxer Willie Lee Shannon of having his "whores" testify to contradict testimony in a prior rape case and possibly the one pending in District Court.

Prosecutor Bill Henry's accusations were part of his argument against a defense motion asking for the medical and criminal records of the victim, criminal records of witnesses and the statements of witnesses in the case.

Judge Donald Mosley granted the motion.

However, he told Henry to hae the 29-year-old victim to submit to a medical examination to determine if she has or recently had a venereal disease, and to turn the results over to the court.

The record will be ex-

amined in the judge's chamber.

Shannon is scheduled to go on trial Feb. 27 on the charges of battery with intent to commit a crime, first degree kidnapping and sexual assault.

He is free on a \$35,000 bond.

## Murder Victim Identified Monday

The body of a murder victim discovered in the desert north of Las Vegas over the weekend was identified Monday as Telisa Harris, 22.

An autopsy showed the Las Vegas woman was bludgeoned with a blunt instrument and later dumped in a desert area near Craig Road and Highland Drive.

A citizen walking through the desert discovered the body Saturday.

## Wham Suspect Set For Trial

A writ asking for the dismissal of murder charges against John Oliver Snow, accused of the Feb. 13, 1983, contract-killing of nightclub owner Harry Wham, was denied Monday in District Court.

Judge Donald Mosley did not agree with Snow's attorney's argument that the state did not have enough evidence to detain his client, who has been held in the Clark County Jail since he was extradited Nov. 7 from New Jersey.

Attorney Joe Houston contended the state's only evidence against

his client was the name which was written on a piece of paper in the possession of Doug Parker, who has been convicted of hiring someone to kill Wham for his wife Peggy.

Sally Cook, the sister of Peggy Wham, testified at her sister's trial that she saw Snow's name written on a piece of paper that Parker had and that Parker said he was the hit-man. She also said Parker said the killer was from the East. Parker is serving two life terms with the possibility of parole for his partin the crime.

Snow is scheduled to go on trial March 26.
