Youth Held In Fetus Slaying

North Las Vegas Police jailed a 15-year-old boy Friday and charged him with murder in the early morning stabbing death of his girlfriend's near full-term unborn child.

The woman, Victoria Hudson, 20, suffered three deep stab wounds with a large kitchen meat knife that punctured both her lungs and the fetus' umbilical cord, police said.

The stabbing reportedly occurred shortly before 6 a.m. when the youth allegedly slipped into Hudson's bedroom in the home of her mother, Emma Nash, 2008 Lawry Ave.

Hudson was lying on her bed when she was attacked, police said.

The woman's screams aroused her family, who called police and an ambulance. Hudson was rushed to Sunrise Hospital, where her unborn baby girl was pronounced dead.

Trial Underway For Man Accused of Shooting Man 9 Times

Testimony began Monday in the District Court murder trial of a 31-year-old man accused of shooting a man nine times in a bar on Bonanza Road.

If convicted of firstdegree murder, Leonard Pedroso Luna, also known as Leonard Pedroso, faces life imprisonment, with or without the possibility of parole. Before the trial, prosecutor Bill Koot withdrew his intention to seek the death penalty.

Black College Ruling On Strike

OXFORD, Pa. - The 70 full-time members at the USA's oldest black college - Lincoln University - remained on strike Tuesday. They're asking for higher pay, better benefits and a greater role in decision making. The university is expected to decide today whether to accept teachers' proposal for binding arbitration. The strike, in effect since Thursday, has meant cancelled classes for the school's 1,100 students.

Luna is accused of killing Rolando Munoz, 29, who was shot about 6:45 p.m. July 25 in Gilbert's Liquor Store, 322 W. Bonanza Road.

Earlier in the day, the 12-member jury was seated in the courtroom of Judge John Mendoza.

In his opening statement to the jury, Koot said Luna walked into the liquor store and shot Munoz nine times. Eight of the shots, Koot said, penetrated the victim's body.
