••• Every time you try to defraud the

Health and Welfare by getting more benefits that you are entitled to just because you are a Union Official the Fund suffers. (EXAMPLE No.1:Bonnie Wemm (real name Bonnie Pearl) Business Agent and a McColl pet, had a face peal and hernia operation in Ogden, Utah. When an inflated lump bill was submitted for payment, Payment was denied for reason that a face peal is cosmetic and an itemized bill seperating the two operations were requested. Instead a loophole was utilized by saying the face peal was free and an inflated fee was submitted for the hernia operation and hospital stay. The Union called four seperate occasions to demand the payment knowing it to be fraudulent. This was not enough. Bonnie Wemm advised several of her coctail waitress friends(one reported this story) on how to get a face peal compliments of the Health and Welfare. Finally a bill of over \$3,600.00 was paid. The unpaid balance of over \$1,000.00 is payable by Maurice M Gedance Insurance that insures all Union employees in addition to the Health and

Welfare. Guess who pays for this second insurance? WE DO EXAMPLE No 2.: When Paul Cohen, the previously non Culinary Administrative Assistant, who actually runs the Union, without being an elected official and is in charge of addressing the Health and Welfare Program chose to have a vasectomy operation, knowing it was not an illness of injury and therefore not coverd by the Fund, he submitted the bill for payment anyway. It was rejected. He appealed it to the Trustees and he lost. Acting as an insurance genius and bieng in charge of addressing the membership insurance problems, we can not help but ask was he fraudulent or ignorant? Either way the Fund suffers.)

OUR SEPERATE FUNDS. When Jeff McColl and Joe Hayes took office the were invited to take a position as Trustees, by virtue of thier office, on the International Health and Welfare Fund they turned down the offer. The above reasons helped create our disasterous situation. If you ask Jeff McColl what happened it is easier for him to blame everything on the previous administration with all the slanderous instinuations and accusations than to explain their mismanagment of the Union as whole
