counted for so much of the job growth.

Much of the new growth is also in industries characterized by low wages and part-time work, such as fast food establishments. Those are important sources of entry-level jobs and are a spur to local economies. But whoever heard of a major national economy based on selling hamburgers?

So regardless of rosy predictions about computerized future, we'll have to make sure our basic industries are not only healthy and competitive, but that they are a source for jobs and opportunities in the future.

To do that, we'll need an industrial policy, Doing nothing at all is a perverse form of industrial policy itself - a deliberate decision to abandon our own industries and workers to the perils of unfair trade practices and ultimate decline.

What kind of industrial policy do we need? At this point, we need only define some policy objectives.

First, sensible policies that treat the disastrous results of industrial decline, such as federally backed retraining and job programs for the unemployed, along with assistance to impacted cities to help them revive stricken local economies.

Second, a cooperative effort among labor, business and government to provide the resources and restructuring that enables endangered industries to survive.

Third, education and training investments that prepare young people for real-world jobs of the future, with emphasis on minorities, who will be a fourth of new labor force entrants, and the poor.

Fourth, coordinating government policies that impact on trade and on the economy.

Fifth, an investment arm that pumps new resources into community development programs and job-creating initiatives.

That's a broadbrushed sketch of the outlines of an industrial policy of the sort that's needed. We can no longer afford those
