# **Caesars Palace Gains Big Hearns-Duran Fight**

Roberto Duran World **Boxing Council super** welterweight title fight, originally scheduled for Nassau, the Bahamas, on June 15, has been moved to Caesars Pal-

ace in Las Vegas on the same date.

The decision was based on a shortage of hotel accommodations available for fans wishing to attend the bout, according to Shelly Saltman of Shelteron, Inc., which is promoting the fight along with Walter Alvarez, Inc. and Gold Circle, Inc.

Hearns, with a record of 38-1 (32 KOs), will be making the second defense of his super welterweight title. Duran, the current World Boxing Association junior middleweight champion, has a career record of 76-5 (57 KOs).

The fight will be held at Caesars Palace 20,000seat outdoor arena behind the hotel.

This scheduled WBC 12-round title bout will also be shown on closed circuit TV and pay perview TV.

WBA has ruled that it would strip Duran of his title when he fights Hearns. Ed Brown of Las Vegas and WBA Regional Vice President, North America, said, "Duran's title will be taken away from him at the moment he steps into the ring." The decision was made at the WBA

The trip dates are as follows:


