Jackson Wins More Funds

MONDALE CLAIMS FULL SWEEP

As he predicted, Walter F. Mondale claimed victory at noon Wednesday in the marathon contest for the Democratic presidential nomination despite Sen. Gary Hart's triumph in the California primary.

"I feel great," said Mondale, who won resoundingly Tuesday in New Jersey and West Virginia. "We had a wonderful evening.'

Mondale shut Hart out in the delegate races in New Jersey, the key to his approach to a nominating majority.

But Hart swept the California primary, winning more than twice as many delegates as Mondale while also winning primaries in New Mexico and South Dakota on the final day of the primary season.

That stalled Mondale a mere 14 votes short of the 1.967 delegate vots that would mean a majority at the Democratic National Convention in San Francisco convention. Hart said "of course" he would continue his fight on to the convention next month

LV OIC Probed Via State Audit

The Las Vegas Sun and the Las Vegas **Review Journal carried** extensive articles last week on a state-ordered audit of the federally funded Las Vegas Opportunities Industrialization Center (OIC).

At last report a FBI spokesman confirmed that the agency is conducting an investigation into alleged financial irregularities at the OIC.

State Community Services Director Linda Ryan had ordered an audit of the OIC records after reportedly learn-ing of irregularities discovered but not disclosed during a previous audit.

James Chaney, OIC's executive director, when contacted by the Las Vegas Sentinel-Voice, charged that the accusations of any wrong-doing were politically motivated.

Extensive audits and investigations are currently underway at the agency.

With 99 percent of the California vote in, Hart counted 205 delegates to 72 for Mondale and 29 for Jackson, who regained federal matching fund eligibility by getting more than 20 percent of the vote in New Jersey.

Combined with the results from the other four states, the Associated Press delegate survey showed: Mondale 1,955.05, Hart 1,226.75, Jackson 374.2, others and uncommitted 275.

ABC News and NBC News have already put Mondale over the 1,967 mark, while the Hart campaign continues to dispute such figures. **CBS** News has Mondale slightly under the magic number.

Jackson, who was stressing unity just after midnight, woke up with a slightly different vision.

"If you have unity without justice, that's cover-up. Party justice must precede party unity," Jackson said on the CBS Morning News, indicating he will continue his fight for changes in party rules.

The primary results had little good news for Jackson, who won few delegates to add to the "Rainbow Coalition" delegation he hopes will be a trump card at the convention.

"This is the end of a very tortuous but effective campaign in the regular season, Jackson said in Los Angeles.


