Plea Bargain Offered In Stabbing Case

A plea bargain has been offered to a 15year-old North Las Vegas boy accused of attempted murder in the stabbing of his girlfriend and murder in the death of her unborn baby.

The prosecution has agreed to drop the murder charge against Sean Thomas agrees to plead guilty to attempted murder, which carries a maximum prison term of 20 years, District Attorney Ron Bloxham said Tues-

"It's a fair deal for all concerned," he said.

Thomas, who is in the custody of his grandfather, is charged with attempted murder in the Feb. 3 stabbing of his girlfriend, Victoria Hud-son, 20. The prosecution also charged him with the murder of the woman's unborn child, who died as a result of the stabbing.

Gov. Bryan Proclaimed May 17 Brown v. Board Of Education Day In State

The Las Vegas Sentinel-Voice received a news release from Governor Richard Bryan's office on Monday, June 4, indicating that he had proclaimed May 17, 1984, as a day for all citizens to rededicate themselves to the ideals and principles of equality and justice in honor of the 30th anniversary of Brown v. Board of Education. The proclamation read as follows:

"WHEREAS, the United States Supreme Court in its historic 1954 decision in Brown v. Board of Education held that segregation in public education is unconstitutional; and

WHEREAS, it served as the catalyst for the shifting of judicial sanctions from that of segregation to desegregation and the elimination of legal barriers to equal opportunities; and

"WHEREAS, Brown formed the basis for enactment of the Civil Rights Acts of 1964, 1965 and 1968, thereby providing greater assurance of equal opportunity in employment, equal access to public accommodations, housing and desegregated education;

"WHEREAS, there continues to be opposition to desegregation at many levels of life and the momentum of the equality of opportunity in all aspects of public life is decelerated; and

"WHEREAS, despite the removal of the more overt legal barriers, blacks are still faced with resistance to meaningful implementation of these civil rights laws;

WHEREAS, this is the 30th anniversary of Brown v. Board of Education;

"NOW, THEREFORE, I, RICHARD H. BRYAN, GOVERNOR OF THE STATE OF NEVADA, do hereby proclaim May 17, 1984, in Nevada, as a day for all citizens to rededicate themselves to the ideals and principles of equality and justice, particularly at a time when this nation should be attempting to transfer the noble pronouncement of Brown into realities.

I further call upon all elected officials and citizens to exert active individual leadership in making equality a reality for all Americans."
