Robinson, a first-term councilman, said that in light of Arrington's frequent problems with the authority board and his dealings with other projects, "I have been getting pressure from the community to fire him."

Robinson added, "I hope he can straighten up his position. At the present time I am still observing what is happening after a year in office, but am at the point where I know something might have to be done."

Bob Hill Reassigned to D.C. Pending Probe Results

Bob Hill, regional administrator of the Economic Development Administration in Seattle, who is currently under investigation for allegedly accepting a \$1,000 kickback from the Las Vegas Opportunities Industrialization Center has been reassigned to Washington, D.C., until a federal probe is concluded. officials said Tuesday.

Meanwhile, Las Vegas officials soon may hand over the results of a city audit showing more than \$50,000 in questioned expenses by the agency to state and local law enforcement authorities.

The City Council also is expected Wednesday to rescind a \$250,000 federal block grant awarded last month to the agency, which operates job training programs for the poor.

Bob Hill, regional administrator of the Economic Development Administration in Seattle, is the target of a probe by the U.S. Commerce De-

partment into allegations he received \$1,000 in 1982 from James Chaney, the director of the Las Vegas agency.

One of nine regional EDA administrtors in the country, Hill is responsible for overseeing federal funding to Chaney's organization.

An EDA spokesman in Washington, D.C., said Hill was ordered to report to the agency's head-quarters, where he will remain until federal officials conclude their investigation.

"Mr. Hill is being reassigned to Washington for an indefinite period pending an outcome of a probe by federal investigative agencies," said EDA spokesman Christy Bakaly.

Las Vegas officials suspended their \$250,000 grant and began an audit after the state Office of Community Services discovered apparent financial irregularities in the records of Chaney's agency.
