### **FIREWORK SAFETY STRESSED** IN CLARK COUNTY

Fireworks add magic and excitement to a 4th of July celebration, but certain simple precautions need to be taken to avoid burns and fires. Lea Thompson, Consumer Education Agent, Cooperative Extension Service, has this advice:

· Roman candles, bottle rockets, spinners, and firecrackers are illegal in Clark County, so buy your supplies from booths in Las Vegas that sell only legal Class C fireworks.

· This has been a very dry year, so do not use fireworks in dry areas and keep lots of water readily accessible.

 Even sparklers get hot enough to cause burns and start fires, so supervise their use.

 Fireworks are illegal in all national forests.

. To totally avoid any risks, take your party to see any of the spectacular public displays that are locally advertised.

### **New Black Cable Radio** Station To Start July 1

The organizers of KBMT, a new Lincoln, Nebraska, cable radio station geared toward blacks and other minorities, plan to begin operation July 1.

The non-profit station will be initially available only on the FM radio service offered by Cablevision of Lincoln. The station will be located at 96.5 megahertz on Cablevision's FM ser-

Station executives hope to receive Federal Communications Commission approval to locate KBMT on the FM broadcast band within a year. Plans call for a 5,000-watt signal, which would be audible throughout the Lincoln area.

Capital City Commun-Broadcasting, founded by James Terry, **Dennis Banks and Arthur** McWilliams, Sr., will operate the station. Terry, Banks and McWilliams were associated with KZUM-FM until last June.

The station's format will feature a mix of gospel, jazz, rhythm and blues and reggae music,

according to Banks, KBMT's program director. Public affairs and news programming, as well as live Sunday broadcasts from minority churches in Lincoln are also planned.

KBMT's call letters stand for "Kept By the Master's Touch," a slogan that's designed to reflect the station executive's Christian beliefs, according to McWilliams, KBMT's executive director. The last three letters also represent the initials of Banks, McWilliams and

KBMT will have no advertising. Instead, the station will be funded by underwriters' contributions, grants, membership fees and payments from the Lincoln churches from which the Sunday broadcasts will originate. The organizers are soliciting charter memberships.

The KBMT studio is located at 2711 Pear St. Several Lincoln commercial radio stations have donated \$5,000 to \$6,000 worth of albums, tapes and equipment to the station.

KBMT will initially operate 18 hours a day.
