School Trustees Call For Defeat of Question 12

Saying it would "jeopardize instruction" and "seriously deplete revenue available to Nevada's schools," the Clark County Board of School Trustees Thursday night unanimously adopted a resolution calling for the defeat of Question 12.

In the strongly worded resolution, school trustees emphasized the potential devastating impact of the tax limitation initiative.

"The fact that this initiative would place a limit on revenue makes it a dangerous proposition. This would be an extremely damaging piece of legislation to enact in a state like Nevada which is experiencing such phenomenal growth," said school board president Lucille Lusk, who also serves as legislative chairman for the Nevada State School Boards Association.

The association, like the district, plans to lobby heavily against Question 12. According to Lusk, there will soon be a statewide coalition formed involving citizens from throughout Nevada, to work for the defeat of the measure.

The amendment provides that revenue derived from ad valorem taxes must not be more than five percent greater than the amount from the preceding fiscal year.

"There's no question in my mind," stated Lusk, "that if this initiative passes, there will be lasting negative implications for education throughout this state."

STATE MANDATES FIRE SAFETY CONSTRUCTION ON 7 LOCAL SECONDARY SCHOOLS

The Clark County School District is facing capital construction costs estimated at \$37 million dollars in order to meet state mandates for fire safety retrofitting and to meet federal concerns regarding replacement of asbestos insulation.

In order to fund construction costs, members of the School Board of Trustees will decide at their July 12 meeting whether to ask the Nevada Tax Commission for short-term "emergency" financing.

According to Associate Superintendent Ed Greer, the projects can be financed from ad valorem revenue generated, without increasing the district's current 30.94 cents debt service rate. Greer notes that the school district is in a "strong position" to request using the cur-
