# 11th member added to 'Ten Most Wanted'

Most Wanted Fugitives" has added an 11th member, John J. Schreiber. Las Vegas FBI office special agent-in-charge,

Alton Coleman, an acgambler wanted for a sixweek, multi-state crime spree including the kidnap-murder of a 9-yearold girl, has been added to the list.

The 28-year-old Coleman, who is out on bond following his arrest for the Feb. 28 rape of a 14year-old North Chicago, III., girl, has been charged with the May 29 kidnapping of a young Kenosha, Wis., girl whose partially decomposed body was discovered nearly a month later in Waukegan, III.

Coleman also is a suspect in the abduction and rape of two young girls in Gary, Ind., on June 18. One of the girls was strangled.

On June 28, Coleman allegedly forced his way into an elderly couple's home in Dearborn Heights, Mich. He reportdly beat the couple with a baseball bat, robbed them of their cash and credit cards and stole their car.

On July 7, Coleman was developed as a suspect in the slaying of a 30vear-old woman and her

The FBI's list of "Ten 10-year-old daughter in Toledo, Ohio. The young girl had been raped, sexually molested and strangled.

Born Nov. 6, 1955, in Waukegan, III., Coleman is described as a black complished con man and male with black hair and brown eyes, 5-foot 10inches tall and weighing 145 pounds. He previously worked as a nurse's aide and used Social Security number 349-50-7471.

> His aliases include: Al Bates, Alton Bates, Elton Bates, Alton D. Coleman, Alton Eugene Coleman, Elton D. Coleman, Pissy Coleman, Al Harris, Alphonso Harris, Robert Knight and Tony Peterson.

> Coleman may be accompanied by 21-yearold Debra Denise Brown. Born Nov. 9, 1962, in Chicago, she is described as a 5-foot 5inch black female weighing 100 pounds. She has black hair, brown eyes and a possible scar on the left corner of her mouth.

Coleman and Brown are suspects in the following crimes:

June 19 — Donna M. Williams, age 25, disappeared one day after reportedly being seen with the suspects in Gary, Ind.

June 24 - A Detroit woman allegedly was robbed by the suspects and ordered to drive them to Toledo. While en route, the woman deliberately drove her car into a truck and fled on foot.

June 30 suspects allegedly commandeered an automobile from two men at gunpoint in Detroit.
