PSC To Hold Hearing On Westside Bus

Nevada Public Service Commission, if it follows staff recommendations, will pull the operating authority from the Westside Charter Service, Inc., it was announced Monday.

A bus company owned by state Assemblyman Lonie Chaney and others could lose its operating license for what state Public Service Commission auditors call "continued noncompliance" with PSC orders and "lax ac-counting controls."

The PSC staff will ask commissioners next week to schedule a public hearing to determine if Westside Charter should lose its permits in light of recent audit findings.

In a news release, the PSC said an ongoing audit showed "serious problems still exist and the company appears in

Woodrow Wilson Resigned Commission Seat — Follows Guilty YOBO Plea

Clark County Commissioner Woodrow Wilson who pleaded guilty last month to accepting a \$5,000 bribe from an undercover FBI agent, has submitted his resignation effective last Friday.

Wilson announced his plans in a letter to fellow board members.

"Let me say that serving with the men and women of the County Commission has been one of the most rewarding and challenging experiences of my life, Wilson wrote in the letter released this morning. "Throughout my political career I have sought effective avenues for responding to the needs of my constituency; the **County Commission has** afforded me such an opportunity."

One June 11, Wilson

and former state Sen. Gene Echols averted a potentially embarrassing two-week trial by pleading guilty to attempted extortion and aiding and abetting in a crime.

Both admitted accepting payoffs from former undercover agent Stephen Rybar in exchange for their political influence. The probe was part of the political corruption investigation code-named Operation

Wilson, 68, accepted \$5,000 on May 27, 1981, in a meeting with Rybar in the office of Doctors Fiduciary Trust, the investment group the agent pretended to represent.

Echols, 64, accepted \$1,000 two days later.

Rybar agreed to give

Wilson a percentage of a \$500,000 project, or \$5,000 after Wilson said, "I'd be happy to use my influence," according to transcripts of tape recordings.

They will be sentenced on Aug. 3 by visiting U.S. District Judge Richard Bilby, who has heard all five Yobo cases.

Several county com-

missioners recently expressed displeasure with Wilson for hanging on so long before resigning and drawing a paycheck without earning it.

It will now be up to Gov. Richard Bryan to name a replacement for Wilson, who would have been up for reelection this year.

A spokesman said the governor hopes to select a replacement for Wilson before the next County Commission meeting.

The leading candidates appear to be Clark County Community College counselor Autumn Keyes, longtime Las Vegas businessman and political figure Leonard
