**Small gains shown in American income**

Americans' income gained against inflation in 1983, the first time in four years, the Census Bureau said Thursday.

The increase "can be attributed to the economy improving between 1982 and 1983," said the bureau's Gordon Green.

The report also shows:

- Median income for whites rose 1.4 percent (\$363) to \$25,757; blacks, up 3.3 percent (\$471) to \$14,506; Hispanics, up 1.2 percent (\$207) to \$16,956.

- Income for women working full-time rose 2.7 percent, from \$13,663 to \$14,479; for men, it rose 0.7 percent, from \$21,655 to \$22,508.

The report also said more than 35.2 million people—15.2 percent of us—lived in poverty in 1983, up 870,000 over 1982 and highest since 1960.

The 1983 poverty level was \$10,178 for a family of four.

The report shows that:

- The rate for the elderly was 14.1, down from 1982 and only the second time it was below the national average.

- The rate for whites rose from 12.0 to 12.1; blacks, 35.6 to 35.7 percent; Hispanics fell from 29.9 to 28.4 percent.

- One in four children under age 6 now lives in poverty; it's one in two of black children, and more than one in three Hispanic children.
