Chiropractors Report Breakdancers Need Conditioning

Break dancers need as much conditioning as football players, ballet dancers or gymnasts to avoid injuring their necks and backs, the International Chiropractors Association said Sunday.

Unless dancers are careful, the whiplashlike movements of head, neck, arms and legs and gyrations of hips and pelvis can cause injuries and the sharp twists and turns can result in weakness, nausea and general discomfort, the association said.

In one case, a 25-yearold broke his neck attempting a break dance movement, the association said.

'We recognize the artistic expression of breakdancing," said Dr. Sid E. Williams, association president and president of Life Chiropractic College in Marietta, Ga.

We want it to be a safe experience and to alert breakdancers to ways to help protect their necks and backs."

Williams said break dancers need preconditioning as much as football players, ballet dancers and gymnasts. Conditioning is especially important for and legs and 10 minutes adults, whose bodies are less flexible than children's or adolescents, he said.

The association suggested the following guidelines:

 Get instruction from professional break dancer, teacher or coach before attempting all but the simplest movements.

· Get professional advice and a checkup before starting to break dance if you have a history of back or spinal problems.

 Do 5 to 15 minutes of warm-up exercises for your back, neck, arms ficult movements.

· Support wrists, hands, ankles and other vulnerable body parts with gloves, elbow and knee pads or tape and bandaging.

· Wear clothing with long sleeves and legs, such as warm-up suits, to help avoid abrasions and provide cushioning.

· Don't break dance alone.

Black woman judge seated

CAMDEN, Ala. - Jo Celeste Pettway, Alabama's first black woman judge, said she hopes her tenure "will be an inspiration for others, just to let people kow it can be done."

Blinking back tears, Pettway was sworn in last week as the new judge of Wilcox County District Court.

"I am indeed humbled, and thankful to God and to all of you who worked to make this day possible," she said after taking the oath of office before 150 friends and relatives.

Pettway, 32, succeeds Anne Farrell McKelvey of Miller's Ferry, who was appointed last week as the first woman judge for the Fourth Judicial Circuit.
