THE TIME IS AT HAND — 1984 PRIMARY ELECTION

September 4, 1984 is "V" Day

"V" stands for votes — the votes, this time more than ever before, will help to shape the real future for all of us, particularly in the black community. All races: Senate District 4, Assembly Districts 6 and 7, Clark County Commission District D and School Trustee District C are focal points for the black candidates. It has been a long hard campaign period for those involved at this time.

In the Senate District 4 race there are three candidates: State Sen. Joe Neal, Logan Fields and David Phillips. Since

there are no Republicans in the race, the top two vote getters will face off in a run-off election in November. The runoff will be conducted even if one candidate receives more than half the total primary vote.

Election Department officials said District 4 has 8,600 registered Democrats and only 894 Republicans.

The primary race in Assembly District 6 will feature a race between four candidates: Incumbent Assemblyman Gene Collins, former Assemblyman Marion Bennett, Gloria Rome

and Jesse Scott.

The winner of the four-way Democratic primary race will face Republican P. Albert Tobin in the November general election to decide who will fill the West Las Vegas seat.

Five Democrats will have their hats in the ring in the primary to represent Assembly District 7.

The Democrat race in this District, being vacated by Assemblyman Lonie Chaney who is making a bid for the Clark County Commission, District D, includes candidates Morse Arberry, Jr., Bob Elliott, Jarvis Holloway, Bill McCurdy and George Ward.

The winner will face Republican Marvin Dixon in the Nov. 6 general election.

Assemblyman Lonie Chaney will face former Las Vegas City Councilman William Pearson in the Democratic primary race in the Clark County Commission, District D.

The victor in the race will face Republican Jimmie Askin in the general

election.

District D seat is now held by Donald Clark, who was appointed to the post by Gov. Richard Bryan when Woodrow resigned shortly after pleading guilty to accepting a \$5,000 bribe from an undercover FBI agent.

In the School Board Trustee race for District B there are four candidates vying for that post which is being vacated by Don Faiss. Included are Bob Duckett, Frank Esparza, Howard Hollingsworth and Gary Livingston.

The race for School Trustee, District C between Trustee Virginia Brooks Brewster and candidate Louise Jordan will be held during the Nov. 6 election.

District Court Judge Addeliar Guy of Dept. 11 is unopposed for the election.

Only 3,486 more voters have registered for the primary election than the 1982 primary, according to County Registrar of Voters George Ullom. He expects to pick up 20,000 more registrations in time for the general election.

At present, 165,990 Clark County residents, or about 44 percent of the eligible voter population, have registered. Other must register by Oct. 6 if they intend to vote in the November presidential election.

59.4 percent of the registered voters in Clark County are Democrats, while Republicans total 34.4 percent of the total. The remainder belong to minor parties or have registered as non-partisan.

The races in the black community are heating up to become one of the

toughest in the area history. The record number of candidates are showing positive interest in the political arena. The one big question that looms now is whether the large number of contenders in each race will be helpful or devastating for the front-runners.

It appears, according to many long-time residents, that the real test will show whether the voters will actually vote their conscience for sincere qualified leadership as opposed to getting involved in popularity contests.
