Sealed proposals will be received by the Directors of the Department of Transportation of the State of Nevada at their District I Headquarters Office, 1200 North Main Street, Las Vegas, Nevada, 89101, until 10:00 a.m., local time, on September 20, 1984, and publicly opened and read on that date at 4:00 p.m., local time, for Contract No. 2051, Project No. IR-015-1(71)25, construction of a portion of the Highway System on I-15 near Jean (Sloan) and US 93 Interchange (Apex), Clark County.

SPECIFIC DESCRIPTION OF WORK COVERED BY THIS CONTRACT CONSISTS OF: CONSTRUCTING RAMPS, CONSTRUCTING FLAT BOTTOM DITCH AND DIKE, CONSTRUCTING CONCRETE SLAB, PLACING BITUMINOUS SURFACE ON RAMPS AND WEIGH STATION, INSTALLING A HIGHWAY LIGHTING SYSTEM.

The attention of bidders is directed to the State Contractor's License Law requirement (NRS 624.230 as amended to date), that a contractor hold a valid license of a class corresponding to the work to be done.
