Boxer Bruce Curry Found Innocent By Reason of Insanity

In a 10-minute nonjury trial, former super lightweight boxing champion Bruce Wayne Curry was found innocent last Thursday by reason of insanity of the attempted murder of his trainer. Jesse Reid.

District Judge Stephen Huffaker, who rendered the verdict, ordered the 28-year-old Curry to the custody of state mental health officials for psychiatric treatment.

He will be confined at Lake's Crossing, a state mental hospital at Sparks. Curry will remain at the facility until psychiatrists determine he is not a threat to society.

The outcome of the trial had been worked out a few minutes earlier in the judge's chambers between Curry's attorney, Joe Houston, and Deputy District Attorney Karen Van De Pol, who argued that Curry was insane at the time of the offense.

Houston said the institution can keep Curry only six months, but if officials believe he needs additional care, they can petition the court for an extension of confinement.

Curry of Fort Worth, Texas, was charged with attempted murder with

use of a deadly weapon and illegal discharge of a firearm stemming from the Feb. 2 shooting at the Golden Gloves Gym, 1602 Gragson Drive.

He was accused of firing a .357-caliber Magnum at Jesse Reid, his trainer at the time,

through a hole in the gym door. Reid was behind a post in the gym, and the bullet missed him by a few feet, according to police reports.

The shooting erupted after Curry blamed Reid for his title loss the previous weekend, court documents stated. Billy Costello captured the crown from Curry in a nationally televised bout in Beaumont, Texas.

Curry, whose brother Donald is a current welterweight champion.

The 22-year-old Cordova, from Albuquerrecord with six knockouts while the 26-yeargeles, has a 26-4 record with 13 knockouts.

Cordova's relentless pressure tactics are working well; he's coming off four most impressive wins. On April 12 in Las Vegas he beat Jimmy Jackson and on June 12 at the Showboat he edged Freddie Roach in a 12-rounder for the ESPN championship in what is considered one of the most exciting fights held in Las Vegas in several years.

Cordova's most recent fights were in Albuquerque on July 14 where he bested Jose Resendez and in Phoenix on Aug. 20 where he topped Ron Gary.

"I know Garcia is tough," says Cordova. "He has to be to have gone all the way with Sanchez for the title. But it's my turn now. I want to fight for the title and to do that I've got to keep winning and get ranked. I'm not going to let Garcia stop me now."

Garcia will be fighting for the first time in 13 months. He's been healthy in that time but, according to manager Jackie McCoy, several fights have just fallen through.

Columbia Presbyterian Hospital Tuesday night for tests and evaluation, a hospital spokesman said.Gerald Dahill, an assistant unit manager of the hospital, said Ali checked in for the second time this month at 9:20 p.m. EDT for an undetermined length. He was discharged from the institute Sept. 11 after five days of testing.

The readmission of the 42-year-old Ali comes amid reports from Europe that the former boxer is suffering from Parkinson's disease, a chronic and progressive disorder of the nervous sytem. The the nervous system. The disease is marked by a tremor and a weakness of the muscles.
