### Penthouse reveals more Vanessa Williams pictures

Williams has filed suit against Chiapel claiming her rights were violated when the pictures were sold, causing her embarassment and lost business opportunity.

Williams was photographed by Chiapel in 1982 while working in his Mount Kisco, N.Y. studio as a receptionist. She claimed she did not sign a release form for the pictures, a charge Chiapel and Guccione have denied.

"Well, Vanessa signed a release, whether she remembered it or not." Chiapel said. "She could have honestly forgotten, but I doubt it.'

The pictures in the November issue again show Williams, 21, of Millwood, N.Y., posing in sexually explicit acts with Amy Geier Wessell, of Boulder, Colo.

According to a recent report, one of two employees of the federally funded jobs agency, who were arrested on theft charges was tape-recorded 21 times by federal agents probing the alleged kickback scheme, according to court documents.

And federal investigators suspect "numerous" other employees at the Job Training Partnership Act office of similar illicit activities.

According to a federal court affidavit, Department of Labor investigators are "aware that numerous employees of the Southern Nevada **Employment and Train**ing Program are involved in unlawful activities similar to those of **Bryiant Williams.**"

Williams was arrested last Monday along with Kenneth Woods following an undercover sting operation at the agency. formerly part of the dis-Comprehenmantled sive Employment Training Act program.
