Civil Rights Activist Passes



Ramon Stewart Scruggs, Sr., age 75, a pioneer for equity and justice in the corporate world and a civil rights activist, passed from this life on Saturday, Oct. 6, 1984. He was the youngest of six children born to Mary Louise Buchanan Scruggs and James Walter Scruggs, Sr. of Nashville, Tennessee. After attending parochial and public schools in Nashville, Tenn., he received his Bachelor of

Arts Degree from Fisk University and pursued graduate studies at that same institution where he later served with distinction on its Board of Trustees.

For a brief period from 1935 to 1939, Ramon worked for the Detroit Urban League and the St. Antoine branch of the YMCA in Detroit. It was during this period that Ramon's love and concern for the needs of young people became

indelibly marked on the minds of all who knew him. His deep affection and caring for others was to be reflected in every area of Ramon's

In 1939, Ramon returned to the business community. Starting in Detroit with Michigan Bell as the first Black hired by that company,

he moved into a series of ever-higher positions in which no minorities ever had been allowed to enter within the Bell System or otherwise. Ramon again began to pioneer as he persevered. In January of 1963, in another historic move, Ramon was promoted to the world headquarters staff

Parking Meters Carry Advertising Messages

— A new form of advertising will line Las Vegas streets this month with the institution of Meter Messages, according to Las Vegas City Councilman Ron Lurie.

The City's 1300 municipal parking meters will be leased to Meter Message Inc. for Cityapproved advertising in the form of adhesive labels. The company will pay the City \$2.25 each month for each meter with a message.

"This program represents an opportunity to boost the City's revenues at no cost to the taxpayer as well as providing local and national businesses with a new attractive outlet to promote their products and services," said Lurie.

In addition to advertisements for business concerns, the parking meters will also carry public service announcements. United Way of Southern Nevada will be the first non-profit promotion for Meter Messages in the City of Las Vegas.

"We are always

seeking ways to serve the public good in partnership with private industry," said Lurie.

Godfrey Harris, Meter Messages president, reports that his company now has 34,000 meters available for advertising across the country. Diversified Junctures, Inc., a Las Vegas marketing firm, will coordinate the Meter Message operation in Las Vegas.

"The addition of Las Vegas will measurably enhance the appeal of this new outdoor advertising medium," Harris said. "Local businesses will be able to reach potential customers literally at the point of action,
