Willie Shannon's jury deadlocked

District Judge Carl Christensen declared a mistrial Friday in the rape trial of light heavy-weight boxer Willie Lee Shannon, when the seven-woman, five-man jury became deadlocked and failed to reach a verdict after 15 hours of deliberating.

Saying he was biased and prejudiced after hearing the evidence against the defendant, Christensen calendared the case for Monday before Judge Donald Mosley for the setting of a new trial date.

Christensen ordered Shannon's bail to remain at \$100,000, which the defendant said he plans to make.

The trial began Dec. 3, and went to the jury Wednesday. Deliberations began early Thursday morning.

After he dismissed the jury, Christensen ac-

cused it of dereliction of its duty.

Although members of the jury refused to say which side the deadlock favored, they did say they felt that prosecutor Bobbie O'Neale "didn't prove the incident happened in the sequence given. It was a very hard case to judge on the way it was presented."

Shannon is accused of sexual assault, first-degree kidnapping and battery with the intent to commit sexual assault involving the alleged rape of a 19-year-old North Las Vegas woman Oct. 19, 1983, in City View Park on West Cheyenne Avenue.

The setting of a new date for light heavy-weight boxer Willie Lee Shannon to be tried on rape charges was post-poned Monday in District Court until Friday.

Burn Center named after Jackson

CULVER CITY, Calif.

— Michael Jackson, who 11 months ago was rushed to Brotman Medical Center after his hair caught fire during filming of a commercial, returned Thursday as the hospital's burn center was renamed in his honor.

Jackson, sporting one of his Sgt. Pepper-style jackets during the auditorium ceremony, waved his white-gloved hand as he posed for cameramen in front of a large bronze plaque bearing his name, likeness and signature. The plaque will be mounted on the wall of the Michael Jackson Burn Center.

The ever-shy entertainer said nothing beyond a quick "thank you" to the 100 reporters assembled for the dedication of the center and the announcement of the newly established Michael Jackson Burn Fund, which will finance reconstructive surgery and entertainment for burn victims.

Both the center and the fund were endowed by Jackson, with a contribution from Pepsi-Cola Co., hospital officials said. The amounts involved were not disclosed.

Jackson, 26, sustained second and thirddegree scalp burns last Jan. 27 when exploding fireworks for a Jackson's Pepsi-Cola ad ignited his hair at the Shrine Auditorium in downtown Los Angeles.


