5 Applied For Trustee Post; Others May Apply

Five persons have applied for the District C seat on the Board of School Trustees of the Clark County School District, vacant since the Dec. 31, 1984 resignation of Virginia Brewster. Prospective candidates have until Feb. 15 to apply.

School board seats are not full-time positions, although members spend a great deal of time attending various meetings and studying the issues. Board members, by law are entrusted with setting district policy and governing the financial affairs of the school system. State statutory provisions pay them only \$50 per meeting, to a maximum of \$200 monthly. The board president and clerk receive \$5 more per meeting. The school board convenes, on the

average, twice monthly but routinely holds several additional committee meetings.

To apply for the current vacancy one must be a registered voter who resides in District C. District C includes portions of downtown Las Vegas, West Las Vegas and North Las Vegas. Residency within the district can be verified by contacting the Clark County Registrar of Voters office.

Among those who have applied to date are Jouise Jordan, who, in the General Election, posted 5,162 votes against Trustee Virginia Brooks Brewster who tallied 5.634 votes. Brewster resigned as Trustee effective Dec. 31 which accounts for the present vacancy.

DuBose testified in dog attack case

Airman 1st Class George DuBose testified Monday he was accidentally locked inside a department store when police officer Charles R. Pierce commanded his dog to attack him and then said, "That's it, get a good piece of that boy."

Airman 1st Class George DuBose testified Pierce's canine partner, Damian, bit him on the left arm after the police officer said "sic him, get him or something to that effect."

DuBose quoted Pierce as saying, "That's it, that's it. Get a good piece of that boy. That'll teach him a lesson."

Pierce's trial on a felony charge of oppression began Monday before a District Court jury of six men and six women in the courtroom of Judge Paul Goldman. He is accused of maliciously ordering his police dog to bite DuBose while acting under his official authority as a policeman.

The judge has sequestered the jury in a downtown hotel so that it will not read or listen to news accounts of the trial.

Pierce, a Metropolitan Police officer for seven years, was suspended without pay after DuBose lodged the allegations.

DuBose, 22, said Pierce's police dog attacked him on Aug. 4 when he was accidentally locked inside a **Montgomery Ward store** at Charleston Blvd. and **Boulder Highway after it** closed at 6 p.m.

DuBose testified Pierce and two other police officers, who had their guns drawn, confronted him in a hallway

DuBose testified Pierce passed in front of him with his police dog. When the dog was about two feet in front of him, DuBose said he asked Pierce: "Sir, can you please keep your dog away from me.

Before he said the dog attacked him, DuBose quoted Pierce as telling

He said he had called the store's telephone operator and a police dispatcher from the personnel office after realizing he had been locked inside. The police dispatcher told him to wait until she could get in.

DuBose said the officers instructed him to turn around and get on the floor face down. He said he raised his arms and told the officers he worked at the store and he had talked to the police dispatcher.

He said one of the officers, Terrence Allen, pushed him to the ground and told him to spread. Allen stomped on his back and his neck with his foot, he said.

DuBose testified the dog bite on his left arm drew blood and left a puncture scar. He displayed his arms to the jury.

Eventually, he said one of the store's managers arrived and confirmed that he was a store employee.
