Henry Dawson bail as slaying suspect set at \$500,000

secution.

Justice of the Peace Joe Bonaventure set bail Monday for Henry Daniel Dawson, Jr., 40, an unemployed clothing salesman who was arrested in the slaying of gasoline station attendant Leslie Gail Shepard after police found blood splattered on the door of the suspect's car.

Witnesses told police that they saw Dawson leave the Stop 'N Go convenience store at Spring Mountain and Industrial Roads with a woman believed to be Shepard.

During a search of Dawson's car, Metropolitan Police recovered a button believed to be from the victim's blouse, said detective Sgt. Frank Jergovic.

Dawson, who told Bonaventure he last worked as a salesman for the Fashion Show Mall outlet of Zeidler and Zeidler, a men's clothing store, has been detained in jail since his arrest on Friday.

Dawson has not been formally charged with murder in the beating death of Shepard. The district attorney's office is expected to submit a criminal complaint charging him with the killing.

During the ball hearing, Bonaventure noted that Dawson had several misdemeanors on his arrest record and was also arrested on a sexual assault charge in 1983 but the case was not approved for pro-

ported missing from her job at the gas station booth at 6:30 a.m., about an hour before her body was discovered, police said.

Police said evidence at the scene indicated Shepard had been bludgeoned in the head with 3-foot pressurized beverage container used to make soft drinks. Such a container was found next to her body and was covered with blood, police said.

Two witnesses told police they saw Dawson and a woman believed to be the victim leave the Stop 'N Go store in Dawson's Lincoln Continental, according to an arrest report filed in court.

One of the witnesses said he saw Dawson drive his Continental

into the gas station before Shepard disappeared. Dawson was alone at the time, said the witness, who resides in the same apartment complex as Dawson at 3873 Vegas Plaza Drive, a few blocks from the gas station.

The witness told police that Dawson drove away from the station with a woman after getting gas, according to the arrest report, filed to establish probable cause for Dawson's arrest.
