Yvonne Atkinson Appointed Trustee On School Board

Yvonne Atkinson, a 28-year-old native Las Vegas, has been appointed by the Clark County Board of School Trustees, to replace former Trustee Virginia Brooks Brewster, who resigned last fall. Atkinson, a 1974 graduate of Clark High School, was selected March 28, by a 5-1 vote of the board, from a field of 10 other candidates.

Atkinson, who holds a political-journalism Bachelor degree and a Master of Public Administration degree from UNLV, said, 'My knowledge of the school system makes me familiar and sensitive to the

many problems which Clark County students may be facing. Now that I am in a policy-making role, I will be in a position to assist parents and students by being available to listen to their concerns and frustrations, and being willing to respond appropriately with our children's best interest at heart.'

She said she is also concerned with providing quality education for college preparation for students, and merit pay for teachers, along with vocational oriented students. She said she wants to maintain an open ear to her

constituents, and urges all who have suggestions, recommendations, and concerns relevant to the district, to feel free to contact her.

Atkinson is a management analyst for the Clark County Comprehensive Planning Department. In her position she prepares and maintains budgets for the departments.

Atkinson was appointed to the Youth Advisory Board of the school district by former Gov. Mike O'Callaghan. She said her

involvement in community activities and constant contact with the public contribute favorably to her being a positive role model and responsible school trustee.

She is a member of the American Society of Public Administrators, Conference of Minority Public Administrators, Alpha Kappa Alpha Sorority and Section for Women in Public Administration, NAACP, and is a former member of the sponsoring committee for the Urban League of

Southern Nevada.

She is a homeowner and the mother of two-year-old Brian.

She is the daughter of Bobbie Atkinson, of 1233 West Monroe Ave. She has three sisters attending college, after graduating from Clark County Schools.

Since she was appointed, Atkinson will have to run for election in 1986. The position is normally a four-year term.
