

The current crisis that is facing the USFL can be traced back to the forefathers of the league who wanted to operate a medium budget organization with a few stars, but instead got into a bidding war of sorts with the NFL, which only drove player salaries in both leagues out of sight.

Futher more, several owners are pushing to move to a fall schedule, which would mean direct competition with the NFL. a sure suicide move on the USFL's part.




The USFL's survival will depend on a number of things, including obtaining a new network contract, along with the clearing up of several court cases.

Additionally, league officials may have to look at consolidation in one form or another - a reduced number of teams in the league, or, yet an even better one may be a merger with the NFL.


