All around us are simply too many "unweeded gardens" and in these, you, who we honor this afternoon, must not allow yourselves to be "nipped in the choked or bud"!....What then are we to make of these sad realities within Black America?

Well, may I suggest that you and I need to do at least three things? FIRST, we must fully acquaint ourselves with the other, more glorious side of our history, as the model for our future.

SECOND, we must resist temptation designed to make us stray from our goals only to become LOSERS. THIR-DLY, we must march forward together at a brisk pace, becoming bright examples of Black excellence.....Your obligation is to continue to strengthen your resistance to temptation. Even in the Lord's Prayer we have the petition: "Lead us not into temptation" and we have the dramatic gospel stories of Jesus' ability to stand "toe to toe" with the devil and resist all of his demonic tem-Black ptations. Arnold Pinkney, TRYING TO WIN YOU Jackson's campaign manager convicted

CLEVELAND - Arnold Pinkney, who managed the Rev. Jesse Jackson's 1984 presidential campaign, was convicted Friday of using his position as a port authority official to maintain an unlawful interest in a public contract.

"I'm innocent, and we're going to appeal it," Pinkney, 54, said after the felony conviction by the Cuyahoga County Common Pleas Court panel, which deliberated about five hours over two days at the end of the fiveday trial.

The jury said Pinkney used his position as secretarytreasurer of the Cleveland-Cuyahoga County Port Authority to obtain an insurance contract for his business, the Pinkney-Perry Insurance Agency.

Judge Robert H. Gorman had dismissed a similar felony charge stemming from payment of a \$4,930 premium, and also dismissed two misdemeanor charges stemming from the sale of insurance to a Port Authority tenant by the agency.

Gorman set sentencing for June 21. The conviction carries a maximum penalty of 11/2 years in prixon and a \$2,500 fine.

Pinkney testified that he signed a \$10,496.44 check drawn on Port Authorityadministered public funds payable to Pinkney-Perry, of which he is chairman and 26 percent owner.

His lawyers argued that Pinkney never sought the insurance deal and did not know of any potential illegality regarding the payment of the premium.

Defense lawyers called several character witnesses, including Jackson.

'I respected his integrity, whether it was with the handling of money or an idea,' Jackson said Thursday. 'Knowing ahead of time that this campaign was going to be scrutinized so carefully, we knew that our judgment could be questioned but our integrity could not. I trusted
