The heart of the government's case is expected to be built on Chaney's testimony. Chaney, who was the head of the Las Vegas poverty agency, pleaded guilty last week to federal charges of extortion and subornation of perjury and agreed to testify as a witness for the prosecution.

He is scheduled for sentencing July 26 and faces the possibility of a six-year prison term.

Hill and Chaney led a list of 11 defendants named in a 36-count indictment returned last December following a lengthy investigation by the FBI. The indictment charged the group with conspiring to divert \$30,000 in federal funds earmarked for OIC into their own pockets.


