Local Students Win Southland Scholarships

LAS VEGAS — Three outstanding local minority high school graduates were awarded the first \$1,000 of a \$4,000 college scholarship by The Southland Corporation and its 7-Eleven stores.

Selected for the 1985/86 college year were Naomi Dorsey, a Rancho High School graduate, Bryan Hanaki, a graduate of Boulder City High School and Wesley Baltimore, a Las Vegas High School graduate. The three are among 39 students from across the country to be awarded the scholarship.

Las Vegas Police Officer Wounded During Narcotic Raid

Six uniformed officers from the Metropolitan Police Department serving a narcotics search warrant to a trailer at 500 W. Miller Avenue were confronted with an unsuspecting situation.

Officer Richard Linton, 32, suffered a rifle shot to his neck as the other officers tried to enter the trailer. The bullet reportedly was fired through the rear door as the officers began their forced entry.

Linton, a six-year veteran of the police force, was reported in stable condition yesterday at Southern Nevada Memorial Hospital

after undergoing surgery, entered the trailer and police officials said. arrested Cornelius James

Six uniformed officers and one plainclothes detective were serving the narcotics search warrant when the 11:15 p.m. shooting occurred, according to North Las Vegas Lt. Dorin Goudreau. After announcing themselves several times, the officers began prying open the front and rear doors, Goudreau said.

The rear door was not yet open when a .223-caliber bullet from an AR-15 rifle was fired, hitting Linton just below his left ear.

After the shot was fired, officers at the front door

entered the trailer and arrested Cornelius James Jr., 27, and recovered the semi-automatic rifle, Goudreau said.

James was booked into North Las Vegas Jail on charges of attempted murder ad possession of controlled substances.

After the shooting, Metropolitan Police reportedly found cocaine in the trailer, police said.

A 22-year-old woman, 5year-old boy and 3-year-old girl also were in the trailer, but they were not taken into custody.

James allegedly shielded himself with the children when officers confronted him in the trailer, but then released the yongsters and surrendered, a police official said.


In the letters, People For offers to provide the stations with a two-minute videotaped statement by its chairman, John Buchanan, a former eight-term Republican
