

Pendleton and Mr. Thomas - our people will be hostage no more." He issued a call to arms for restoration of hope and dignity to the hopeless and oppressed. Leland said that if this call to arms is not answered, then this generation will disgrace the legacy of those who have died in the struggle for human dignity in America. He emphasized that "this Administration and our Justice Department have written a history that can be characterized only as an attempt to discredit and destroy those federal initiatives which America's covenant with her people. No one personifies this effort more than William Bradford Reynolds - unless you take Clarence Pendleton seriously.

Leland ended by urging the audience to unite aggressively to get the 1985 Restoration Civil Rights Act passed, which is being blocked by the far right's religious views of attaching the abortion amendment to the bill.

Senator Bob Dole, who has his eyes on the White House in 1988, spoke of his recent meeting with prominent Black leaders as a healthy dialogue. The leaders told him there of the perception that the Republican has turned its back on the principles for which Lincoln fought. In trying to dispel that idea, Dole cited his understanding of the poor because his grandparents were on welfare. He further emphasized that five Republicans worked for fair housing, civil rights, social security COLA, affirmative action and inner-city improvement. He left out the Republican blockage of the '85 Civil Rights Restoration Act, and its refusal to go to conference on the Antiapartheid Act. Dole urged Blacks to join the Republican Party

Representative William Gray, Chairman of the House Budget Committee, stopped short of urging the people to continue in the Democratic Party, but instead, he told them to examine clearly the record and then consider party affiliation.


A great highlight of the meeting was the arrest of 41 League members, including John Jacobs, marching in front of the South African embassy, and the discussion

of apartheid by Randall Robinson, Executive Director TransAfrica. who originated the daily marches before the embassy, and Dr. Allen Boesak, President of World Alliance of Reformed Churches, Republic of South Africa. Robinson told how the U.S. is underwriting the most vicious system in the world, by its more than two and a half billion dollar investment in South Africa. He said, "we have computerized apartheid and we do not want our shackles polished.'

Dr. Boesak praised the U.S. Free South Africa Movement. He pictured the horrors of partheid, and told how South African Whites have interpreted the Bible to fit their actions. He criticized those who say that U.S. divestment will hurt Blacks by relating that only a few Blacks benefit from U.S. corporations who operate in South Africa only for making money. He said, "give me the right to decide my suffering!'
