LAS VEGAS - Governor Richard Bryan recently approved the creation of enterprise zones in Las Vegas and North Las Vegas. Enterprise zones were enacted by the 1983 Session of the Legislature. They are areas targeted as having trouble attracting business. Under the enterprise system, local government can do special things to make those areas more attractive, like waiving fees, lowering license costs, and setting different regulatory requirements.

The governor appointed the Director of Economic Development, Andy Grose, as administrator of the enterprise zones.

"With the Bryan said, creation of these two enterprise zones, community developers in Las Vegas and North Las Vegas have a new tool to attract business and revitalize substandard areas. It is another part of our overall commitment to economic development and diversification.'

All cities and counties in Nevada were invited to apply

for enterprise zone creation. Only Las Vegas and North Las Vegas did.

The cities of Las Vegas and North Las Vegas applied for and the Governor approved the creation of "enterprise zones" enacted the Legislature.
