

Mobs of dissenters kill two in South Africa

JOHANNESBURG, South Africa -- Mobs of blacks killed a laborer and a bus driver in anti-apartheid violence, and police said they were trying to determine how a black political activist died in custody.

Officials said Tuesday that 35-year-old activist Mbuyiselo Mbotya died in police custody in East London, outside Port Elizabeth, on Saturday. He had been detained a day earlier.

Colleagues said Mbotya was a member of the United Democratic Front, South Africa's largest multiracial anti-apartheid group. He was the 11th black in 18 months to die in custody.

Police said they were investigating Mbotya's death, and offered no explanation for it. By unofficial count, more than 65 people have perished while being held by police in the past 25 years. Only one of them, a trade union organizer, was white.

A gang of blacks waving

axes mobbed a 62-year-old man and hacked him to death, apparently because they considered him a collaborator with the white-minority government, police headquarters in Pretoria said.

Police said they arrested 33 blacks between the ages of 18 and 33 in Zwide, a black area outside Port Elizabeth, after they killed the man, a black laborer employed by the township council.

The councils, white-created bodies to hold limited power, exist in most black townships, but fewer than 10 percent of the population generally participate in voting for them. Militants accuse council members of collaborating with white rule.

Another black, a 20-year-old bus driver, died Tuesday in Guguletu, near Cape Town, when a mob blocked the path of his vehicle and set it on fire, police said.

Young blacks, who regularly attack vehicles in the township, have tried to

held bus service as part of a campaign to create anarchy in Guguletu. The township has been torn by anti-apartheid rioting for nearly a month.

More than 700 blacks have been killed in 13 months of rioting against apartheid, the government's racial separation policies, according to independent monitoring groups. More than half were killed by police at riots or demonstrations.

"It's encouraging that we have the option to suggest to students that they can complete their lower-division requirements at the Community College," said Everett. "Then they can return to National and complete a degree.

"The impact of this Articulation Agreement will be great, especially as National becomes more and more familiar to Southern Nevadans," Everett observed. "The total educational process of working toward and obtaining a college degree can be completed in Southern Nevada and it doesn't make a difference if the student is a recent high school graduate, a returning college student looking to complete a degree, or a full-

time working person seeking to earn an advanced degree while pursuing a career.

The National University Southern Nevada campus is the newest campus for the San Diego based university. Founded in 1971, the university currently has 10 campuses located in California at San Diego, National City, Vista, Palm Springs, Irvine, Inglewood, Oakland and Sacramento; San Jose, Costa Rica; and Southern Nevada.

National University currently offers degree programs in Business Administration, Management, Computer Science, Behavioral Science and Education. All courses are scheduled on a month-long basis with classes at night and on some Saturdays to accommodate working students who cannot attend class during traditional school hours.

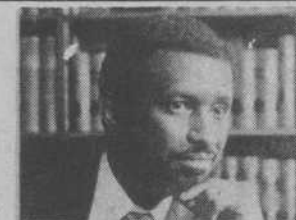
Jobs for the Handicapped Training Pays Off
