
Crawley began his training in the Ormsby House's Grand Terese ballroom. Bramble is training daily at the MGM.

Tennis Tip

When serving and volleying, you must make a splitstop before you hit the volley. The stop is usually made just before the service line. You said you are quick, so you should be able to get there. You carry a lot of momentum running to the net after hitting a serve, and the combined force of your volley and service momentum will make it difficult to control the ball. Coming to a stop will allow you to get yourself set and hit a controlled volley.
