Union members urged to file job complaints

All EEOCV, Local #357 and J.A.T.C. members: This appeal is made to Union members and apprentices of Electrical Union Local #357 to file complaints if you feel that you have been discriminated against because of your color.

These complaints should be sent to EEOC, 3660 Wilshier Blvd., Los Angeles, California 90010, c/o Atty Marilyn B, Hardin.

If you have been denied membership in the Union or the apprenticeship program or terminated, demoted or suspended without just cause or due process, this may be the basis of a complaint.

If your work assignment or work product has been evaluated or accessed differently from that of white members, this kind of disparate treatment may be a good reason to file a complaint.


The Union and J.A.T.C. have filed a motion with the court to dissolve the 1973 decree claiming that they have met the goals of the decree in that minorities now constitute 9.5 of the Union membership and are now being referred for work without regard to their race, sex, or national origin.


Previous seminars were held in Atlanta in March and Dallas in June, Detroit in August, and Atlantic City in October. All black
