Transportation. This \$637,565.00 project, approved by the Regional Transportation Commission in May of 1984, is being constructed at the corner of Bonanza Road and "H" Street. It will comprise 4000 square feet of administrative space and four maintenance bays as well as parking area for more than 50 vehicles.


