# Local Chapter SCLC picketed State Building

Members of the local chapter of the Southern Christian Leadership Conference Wednesday picketed the State Building, asking Gov. Richard Bryan to lead economic development into the Black community.

Ed Smith, SCLC president and Bob Lawson, chapter vice president, said they were picketing on Dr. Martin Luther King's birthday, along with about 10 other people to emphasize that Nevada had "written a bad check to Blacks in Las Vegas.

Smith said the check guaranteed Blacks certain rights, which the State had reneged on.

He continued that the Black community had been promised the location of bank branches, but that promise has not materialized, causing instability in the community.

He said money only comes into the community through welfare and federally funded programs.

Smith revealed that SCLC wants Bryan to go to local banks and get them to conduct a feasibility study on the possibilities of locating bank branches in the community.

He said Highland Drive and Owens Avenue are good places to locate businesses, but the community is still barren because of redlining by banks, causing them not for loan money to development.

According to Smith, the West Las Vegas community is the only one in the country where redlining still exists. He said the rest of the world

is living in the space age, but the Black community is still "S0 far backward economically." Smith said, "We want our

youngsters to become police

officers, tiremen. businessmen and to have trades so that they can be independent, and not end up in prisons or a welfare
