

Dog Search Continues New Courses offered 'Call Before You Dig'

Race and Sports Book -Course at CCCC

The Resort Occupations Program at Clark County Community College will offer two courses in Race and Sports Book Operations during the spring semester.

Race and Sports Book Ticket Writing is a course designed to prepare participants for entry level employment in Nevada Race and Sports Books. The course will meet Tuesday evenings from 6 p.m. to 8:55 p.m. over a six week period commencing January 28 and concluding on March 4. Cost for this one credit hour course is \$70.50 which includes tuition, fees, and all instructional material.

Race and Sports Book Management, a three credit hour course, stresses methods and techniques required in the successful management of a Nevada Race and Sports Book. This course meets Thursday evenings from 7:30 p.m. to 10:20 p.m. commencing January 30 and concludes May 15. Course cost is \$61.50 for the semester.

The latest information on maternal and child health is. in, and the news particularly for the Black community - is very bad. In 1983, the most recent year for which we have a complete national picture, the health of mothers and children suffered several major setbacks.

While our nation's overall infant death rate is at an alltime low (11.2 deaths per thousand live births, as of 1983), our progress in reducing the death rate has slowed dramatically in recent

And the progress we have made as a nation in saving infant lives has not helped Black mothers and infants as much as white infants. The longstanding gap between Black and white infant death rate has widened still further. Black infants are now nearly twice as likely to die within their first year of life as white infants.

With regard to deaths occurring within the baby's first 28 days of life, progress has slowed especially dramatically among Blacks. During 1979-1983, the decline in the Black death rate was only half what it had been for the previous five

We in the Black community cannot let these tragic numbers continue to rise. We know that access to early and complete prenatal care can help prevent infant deaths, we must band together and press our government to make sure this is available to every mother who needs it. Several of our Black leaders have given us an excellent example of how to fight to save babies' lives - and win.

One such leader is Virginia State Senator Bobby Scott. He finds high rates of infant death or suffering "unconscionable" because death or they are so often preventable, and has been working for years to turn these trends around by providing low-income women with the prenatal care that can help them have healthier babies.

Arguing that "we save more money than we spend by providing prenatal care,' Scott led the successful fight to get Victoria to offer Medicaid coverage to firsttime pregnant women. He is currently chair of the state's task force on infant mortality, seeking to keep the issue high on the state's agenda.

Scott believes that others

in the Black community can help save babies by 'developing statewide constituencies to address concerns to their governors and health departments.'

He urges all of us to make the need for prenatal care a political issue, telling our politicians "if no action is taken today, they're going to hear about it tomorrow.
