NAACP March For Human Dignity

On Monday, June 2 the Las Vegas Branch NAACP will stage a March for Human Dignity in South Africa and at home. A core group of twenty-five NAACP marchers will leave Los Angeles on June 1 and arrive in Las Vegas on June 2 at 3 p.m. This contingent of marchers will be met by NAACP members and friends who will march with them beginning in the vicinity of the Hacienda Hotel and proceed south on the Las Vegas strip to the Federal Building on Las Vegas Blvd. South and Bridger Street.

This will be the first march staged by the NAACP in Las Vegas since the Civil Rights Days of the 60's. The public is invited to put on its walking shoes and come march with us.

NAACP Marchers Against Apartheid in South Africa

Just as segregation and discrimination are evil, ungodly, unchristian, inhumane and un-American forces so is Apartheid in South Africa.

Therefore all of God's children of Good Will must stand up and march together. Around the world, people of all nationalities, colors and creeds are joining hands and hearts against that devilish diabolical system of slandering known as Apartheid. Old and young Americans do have a "Common stake" in many of the social welfare programs now on the budget chopping block, according to Mary Bourdette, Director of Government Affairs at the Children's Defense Fund. "In 1984, 10.3 million children and over a million

Edward Roybal (D-CA), summed it up well: 'To the extent that we have made progress in improving the economic security of older persons -- the nation can be proud -- to the extent that children are being driven into poverty -- the nation must move immediately to pull them out. 
