

His long term goal is law school. Not only has Carl done very well in academics, he has also participated in sports in college. He placed second in the Western Regionals in boxing in 1982-83 and in the same year placed third in the NCAA finals held at Colorado Springs. He has also participated in other extracurricular activities - Black Student Organization and Resident Assistant at White

Cuba's Stevenson impressive tourney

RENO - It took Cuban superheavyweight Teofio Stevenson just two minutes to answer doubts about his right hand Tuesday at the 1986 World Boxing Championships.

The question was raised Saturday after his first-round decision over East Germany's Ulli Kadan, who seemed unaffected by the Cuban's famous right hand. Halfway through round one of his second match, three snapping rights knocked Bulgarian Petar Stoimenov into the ropes.

The fight lasted only a few seconds after the standing eight count before Stevenson hammered Stoimenov with a right hand that left him wobbling and hanging onto the ropes. The referee counted him out at 2:00 of the first round.
