#### Howard Gets New Dean, Blasts Old Dean, Media Views-

WASHINGTON, D.C. -NNPA) — Howard University President, Dr. James E Cheek appointed Prof. Clay Smith, new dean of the law school to replace Dr. John T. Baker immediately following controversial media coverage of a campus dispute over law school students seeking graduation. Of 13 senior petitions, nine were approved by university officials and four were denied among the approximately 100 graduates at the

school's separate west side \_ campus.

Calling a press conference to announce the appointment and "correct inaccurate media reports," Cheek stated "all of the students whose petitions were granted, as a result of the appellate review . . . were academically qualified to graduate. The University resents the charges that it lowered its academic standards for any of these students. That is unfair to

them, their classmates, the Law School, its distinguished alumni and Howard U.''

He singled out the Washington Post newspaper as "having done an injustice to the University and damage to me and my reputation as an educator and universeity president. "He later told reporters he would seek to determine "how much damage" was involved in the action of the newspaper and the dean.

The matter of the law students is entirely unrelated to Dean Baker's resignation, however, Dr. Cheek stated.

In appointing Smith effective immediately, he emphasized he had "lost confidence" in Baker's "ability and commitment" last March 30 when the dean wrote requesting a \$25,000 increase in his \$93,000 salary because of urgent financial requirements.

Baker also indicated he was

considering returning to the Indiana U. School of Law where he was a faculty member before being appointed to Howard last year. The former dean is a Howard Law School graduate.

Declaring that Howard is already more integrated than most law schools, Dr. Cheek said he disagrees with Baker's assertion that the school should be ''more racially diverse.''
