in high schools in Texas, Maryland, and Nevada. He was also a member of the Future Farmers of America in High School. In college, he was president of the Forestry Club in 1982-83 and was Vice President of the Black Student Organization in 1984-85. He maintained a 3.0 GPA in college. I asked David how much more studying it took in college compared to high school to maintain essentially the same GPA he had in high school. He said it took nearly three times as much studying to maintain the same average in college. David participated with Mark in the National Park Service Internship Coop Program and just got a notice of a permanent job with the agency.

Both Mark and David said they must have written nearly 50 full reports and term papers during their college careers. Thirty-five of these were in their major field and the other fifteen in other courses.

David said that he attributes his college success to a great mother and father who instilled in him confidence in his ability.

Mark stated that after he earned the Associate degree, he decided he couldn't compete effectively with four-year degree persons, particularly since management was his goal (and he is absolutely correct.) Mark also served 31/2 years as a UNR reserve policeman. Mark is also good in mechanical things. This he attributes to the years he spent working on the family car with his mother

understand that and back the legislation — if a vote were held today it would pass overwhelmingly, despite Administration misgivings.

But the Bill has been sidetracked by abortion-related amendments sponsored by anti-abortion groups. Whatever the merits of the abortion issue, it should not become a torpedo that sinks a crucially important civil rights bill.

Civil rights gains are in deep danger today, and preserving those gains must take precedence over other issues. I know the backers of the abortion amendments are concerned about civil rights as well as about abortion, but by mixing the two they accomplish nothing for their cause while severely damaging the cause of civil rights.

It is to be hoped that they will withdraw their attempt to use a civil rights bill as a platform for their beliefs and allow a ''clean bill'' — one free of controversial amendments — to come to the floor of Congress.

Given the Administration's aggressive attempt to misuse the Grove City decision to weaken overall federal rights enforcement, passage of the Civil Rights Restoration Act is a must.
