district should have a black representative.

The Rev. Jesse D. Scott, president of the Las Vegas branch of the NAACP, agreed.

"We just want to have representation in our city government," Scott said.

After listening to the concerns, Councilman Al Levy said he would meet with McMillian, Scott and unsuccessful council candidate Lois Larson on Friday morning to consider new boundaries.

Deputy City Manager Randy Walker, who helped determine the proposed boundaries, told councilman that it would be difficult to add new election precincts to Ward 3 without exceeding the 5 percent limit.

Walker said the new boundaries had to be drawn up because growth in the northwest portion of the city had increased Ward 4 to be more than 55,000 residents, compared with almost 44,000 in Ward 1, slightly more than 50,000 in Ward 2 and more than 48,000 in Ward 3.

Metro schedules road checkpoint

Metropolitan Police plan to set up a roadblock to check for drunken drivers on Lake Mead Boulevard during the Memorial Day weekend, a traffic bureau spokesman said.

The checkpoint, scheduled for Sunday, will be located five miles east of Nellis Boulevard.

Police said the checkpoint is planned to coincide with the large crowds that are traditionally drawn to Lake Mead during the Memorial Day holiday.

Officers hope their checkpoint will deter drivers before they get into their cars if they are drunk.

Drivers will be questioned by officers at the checkpoint but they will not be asked to get out of the car unless the officer suspects intoxication.
