Attorneys for former heavyweight boxing champion Muhammad Ali fought to block a request to dismiss his federal lawsuit against the government for denying him conscientious objector status during the Vietnam War. Attorneys for Ali, who was stripped of his heavyweight title and not allowed to fight for three vears after being convicted of draft evasion in 1967, said that, in 1966, high-ranking Justice Department officials overruled a lower agency decision that Ali should be given conscientious objector One of Ali's status. attorneys, former Justice Department official Jerry Leonard, said there was a "conspiracy" among highranking officials because Ali were granted conscientious objector status exempting him from the draft, other blacks were seek the same status...Sugar Ray Leonard, boxing under the assumption that Marvin Hagler will agree to fight him, went through a vigorous workout Monday preparation of what he said would be "the greatest fight in history." Leonard, who has not fought in two years,
