Sparks revs up for **Festival** Days

John Sparks, Nevada governor from 1903 to 1908, will be the honored quest -in memory, at least -- at the third annual Sparks Festival Days June 11-15.

The basic intent of the festival is to honor John Sparks and to call attention to Sparks as a community. Mabry. said Karen spokeswoman for the event. 'It will provide some wholesome family activity."

The festival, to be held in the Silverada Mall parking lot on Oddie Boulevard -- behind the Lucky, Long's and Montgomery Wards stores -will include a "full carnival" of amusement rides, Mabry said. In addition, there will be booths featuring food, games, arts and crafts and other attractions.

Also planned are a dog show, a battle of the bands and an array of city officials, political candidates, beauty contest winners, Bertha the elephant and other minor nobility of the Rail City.

The dog show, coordinated by the Sparks Leisure Services Department, will be a "fun type of show," said Carol Balaam of the Sparks Community Chamber of Commerce, sponsor of the festival.

Hicks said kids may register their dogs on the day of the show. It will begin at "around 11 in the morning" on Saturday, June 14.

"We're hoping for eight or 10 good bands," Lee added. 'The first prize is \$1,000, so we should get a pretty good turnout."

8 percent home loans available -- for some

plan offers a 7.99 percent mortgage interest rate on about 700 homes for low and moderate income families.

Mamie Chinn, deputy administrator of the Nevada Housing Division, said the money for the mortgages come from a \$150 million 1984 bond for use in the low interest loan program.

The remaining \$47 million in the program is available to finance homes at a rate of 7.99 percent, she said. provided that individuals or families fall within the income limits specified in the

"The 7.99 percent is the lowest rate offered by the housing division since 1979 and is probably the lowest offered by any state housing finance agency in the United States for this year," she

The rate is available on 30year, fixed rate mortgages, she said, and within the program's limits should finance acquisition of about 700 homes statewide. Homes must be either FHAinsured or VA guaranteed.

Income limits for first-time buyers range from \$27,032 for individuals to \$43,438 for a family of six or more.

Any new or existing home is eligible within price limits of up to \$87,250 for new

A new Nevada housing homes and \$100,760 for existing homes

The program is designed, Chinn said, for the first-time homebuyer or people who have not had a home investment in the previous three years

Since 1977, she said, the division has financed more than 7,500 single-family homes with more than \$400 million in loans.

Kenneth Lynn, executive director of the Economic Development Authority of Western Nevada, said the program should help the Reno area provide housing for its growing economic base "if we get our proportionate share.

Robert Jones, executive director of the Builders Association of Northern Nevada, said the rate is almost a full 2 percentage points lower than the conventional level.

'I think that makes it easier for more people to get into home ownership and they'll become better citizens for the community," he said.

He also cautioned that this is the last of the money available from the earlier bond issue and because of tax law changes pending in

'This is an excellent time for people to take advantage of the program," Jones said.

McKay is seeking intervention by the 9th* Circuit Court of Appeals in San Francisco to put the process on hold until Nevada officials have the opportunity to comment on environmental assessments that were released today

In a release issued today, McKay said he would advise the court that the selection process is illegal and is geared to make Yucca Mountain the only site under consideration for the repository.

In a seperate petition, McKay planned to argue that the Department of Energy necessary lacks the jurisdiction over Yucca Mountain. The attorney general will ask the appeals court to allow Nevada to spend Energy Department funds to seek a court review midnight June 14 and noon of the department's decision regarding the repository selection process.
