The dates of June 29 through July 3 have been set for observance of the 77th Annual Convention of the National Association for the Advancement of Colored People, will be held in Baltimore, Maryland. The NAACP is the oldest, largest most respected and feared Civil Rights organization in the world today. Delegates from all fifty states and 2200 branches will be present with their families and friends. More than 20,000 delegets are expected to be in attendance, including 1000 youth. WEST LAS VEGAS HEADED FOR FIGHT WITH CITY COUNCIL ON REALIGNM

West Las Vegas leaders Tuesday appeared headed for a confrontation with the Las Vegas City Council over the predominantly black community's attempt to increase the chances of a black councilman being elected.

were Councilmen scheduled to consider an ordinance today that would realign council wards to compensate for rapid growth in northwest Las Vegas.

Black leaders have asked that the ordinance be amended to add four largely black election precincts to Ward 3, which already encompasses much of the Westside.

However, their proposal will not be recommended for council approval by City Councilman Al Levy, who

If the council rejects the amendment, the city faces the threat of a lawsuit from the local chapter of the National Association for the Advancement of Colored People.

"I see no alternative but to go to court," said the Rev. Jesse Scott, president of the NAACP's Las Vegas branch. Scott said that city ordinance would draw lines between the wards that would "render impossible" the chance that a black person would ever be elected to the council.

Clark County Commissioner William Pearson is the only black who has served as a Las Vegas city councilman. Pearson was appointed to fill

Bradley, Deukmejian go for rematch

LOS ANGELES-Republican Gov. George Deukmejian and his Democratic opponent of four years ago, Los Angeles Mayor Tom Bradley, defeated political unknowns by wide margins in their respective primaries and will face each other in November in a rematch of their 1982 race

Deukmejian won 94 percent of the Republican vote against Bill Clark, a politically unknown electrical engineer who did not campaign actively, and Bradley took 79 percent of the Democratic vote against four political unknowns, led by flea market operator Hugh Bagley, who spent 71/2 hours of election day in jail for refusing to pay a traffic warrant.

The primary's other top race was over Proposition 51, a complicated statewide ballot initiative which would limit liability claims in multidefendant lawsuits. The meausure led 2-1 in a vacancy in 1982 and lost the seat to the current Ward 3 councilman, Bob Nolen, the black community is entitled to a representative of the council.

They said a black person can win in Ward 3 if the number of black voters there is increased by adding four precincts west of the ward boundary. The precincts fall between Lake Mead Boulevard, Washington Avenue and Decatur Boulevard.

The additional precincts, taken from the rapidly growing Ward 4, would raise the number of black voters in Ward 3 by one-third, to about 40 percent from 28 percent.

In contrast, the proposed ordinance would balance the city's population among the four wards by moving some voters out of Ward 4 into Ward 2 and some of the Ward 2 voters into Ward 1.

The four largely black precincts sought by the West Las Vegas leaders would remain in Ward 4, which has been most affected by the city's growth.

Except for the addition of one precinct partly bordered by Eastern Avenue from Ward 1, Ward 3 would not be affected by the ordinance.

Adding the mostly white precinct to Ward 3 would dilute the precentage of blacks and further decrease the likelihood that a black councilman would be elected, West Las Vegas leaders have said.

Nolen, who said he plans to run for re-election next year, criticized the proposed changes in the ordinance as gerrymandering.

Gerrymandering is a term used to describe the unfair apportionment of voters to benefit one group over another

"Is it fair to make one ward 40 percent black just to ensure that one segment of the community has someone on the council?" Nolen asked.
