Inc., a light industrial plant that will refurbish airplane tow trucks and should employ about 200 people.

Another major tenant will be the Southern Nevada Employment and Training Program, which will relocate its administrative headquarters from downtown to Nucleus Plaza, probably in August

The presence of a grocery market, a post office, a restaurant, a beauty shop and ice cream parlor, together with offices for the Black Chamber Commerce, the National Association for the Advancement of Colored People and Clark County Juvenile Court services, has transformed Nucleus Plaza into the economic and office hub of the Westside.

Just five years ago the same site looked blighted, with boarded store fronts and trash scattered in its parking

"Without local interest, this turn-around wouldn't have been accomplished, said John Edmond, president of Nucleus Plaza Inc. "It's the first time that local businessmen have taken interest in owning and managing the largest commercial establishment in the area.'

The corporation raised money by selling stock and by availing itself of an urban development grant from the city of Las Vegas.

We must be doing something right," Edmond added. "because we've had to turn away five or six tenants.

The success of Nucleus Plaza shows that the Westside can support diverse retail and commercial activity, Edmond said,

despite the feeling among most lending institutions that the area is a poor risk for

"Most of the businesses on the Westside are local,' he said. "We still have not been successful in attracting national franchises, such as fast food stores and a major discount store, in the heart of the Westside.

Part of the problem is that the Westside, with a population of about 38,500, still may lack a large enough pool of potential customers to support a major franchise store. Also, many of these chains and many banks do have stores located on the fringes of the black neighborhood.

Nevertheless, Edmond said, the major problem is the public perception that the Westside is too poor and too rough to support a major business.

"I've been in a lot poorer and rougher neighborhoods in large cities, Edmond countered, "and yet these neighborhoods have their own banks and supermar-

Edmond said it's going to take local residents such as himself to turn that public awareness around. Edmond grew up on the Westside and later became a baccarat dealer with several Strip casinos
