## **Firewood Cutting Permits Available Through BLM**

Permits for gathering firewood on Bureau of Land Management administered lands in Clark and Lincoln Counties are now available through the Bureau of Land Management's Las Vegas District Office and the BLM's Caliente Resource Area Office in Caliente, Nevada

Permits are valid for the month issued only. Clark County firewood harvest season runs from October 1st through December 31st.

Permits are issued for dead or downwood only in the Spring Mountains and are limited to one cord per family per season at a cost of \$12 per cord.

The BLM cautions that only a small quantity of firewood is available in the Spring Mountains, and harvesting enough to make up a cord will involve a lot of hard work and travel.

Firewood in Lincoln County is plentiful. Both dead and down greenwood may be harvested year long through permits issued by BLM.

## **HUD** auction a huge success

LAS VEGAS - Last April, it took the U.S. Department of Housing and Urban Development only four hours to auction off 99 homes it had foreclosed upon.

auction first experiment in the Las Vegas area was deemed a success, Tom Webster, manager of the local HUD office, said.

"HUD is probably the biggest real estate broker in town," Webster said. Right now, HUD holds \$56 million worth of property in southern Nevada as a result of foreclosures by lending institutions, which had extended the loans with the understanding they were insured by HUD.

When the buyer falls

HUD then becomes responsible for making future payments, averaging about \$600 a month. "If we

have 1,000 homes in our inventory each month, that costs the taxpayer about \$600,000 each month to carry it," Webster said.

Las Vegas, in proportion to its size, has a large inventory of homes that have been foreclosed upon.
